

## **Bill of Rights Project**

Your assignment will be to construct a cartoon video using Go! Animate involving an alleged Bill of Rights violation. You will create your own situation with teacher guidance. Research of court cases that determine the outcome of alleged violations of the amendment will be utilized in your video, as well as a description of the amendment and a description of your situation.

You will be graded according to the rubric provided.

## **Step 1: Choose an amendment:**

First Amendment -- Freedom of speech, religion, press, and assembly Second Amendment -- Gun rights Fourth Amendment -- No unreasonable search of your house or belongings Fifth Amendment -- Right to a trial, etc. before life, property or freedom is taken away Sixth Amendment -- Right to a quick, fair trial Eighth Amendment -- No cruel or unusual punishment

If you choose one of the other 10 Amendments, it may be difficult to do this project!

Step 2: Find or think a real-life situation where your amendment would be violated. Describe your situation.
